FORKIDS PROVIDES EDUCATION, HOUSING AND CLINICAL SERVICES TO HOMELESS OR IMMINENTLY HOMELESS FAMILIES IN SOUTHEASTERN VIRGINIA. IN FY12 FORKIDS SERVED 336 FAMILIES WITH 671 CHILDREN IN ITS PROGRAMS. ON ANY GIVEN DAY, FORKIDS SERVED APPROXIMATELY 150 FAMILIES WITH 300 CHILDREN. 88% OF FAMILIES EXITED FORKIDS TO APPROPRIATE HOUSING DURING FY12 AND 90% OF FORKIDS KIDS ADVANCED TO THE NEXT GRADE IN SCHOOL. SERVICES INCLUDE TUTORING, CASE MANAGEMENT, COUNSELING, GED CLASSES, EMERGENCY SHELTER, RENT & UTILITY ASSISTANCE AND A REGIONAL RESOURCE AND REFERRAL CALL CENTER. GOOD MOJO, THE FORKIDS THRIFT STORE OPENED IN FY12 WITH A GENEROUS SEED-FUNDING GRANT FROM THE HAMPTON ROADS COMMUNITY FOUNDATION. THE PRIMARY GOAL OF GOOD MOJO IS TO PROVIDE FAMILIES WITH THE ESSENTIAL HOUSEHOLD ITEMS NECESSARY TO SET UP HOUSEKEEPING IN A COST NEUTRAL MANNER FOR FORKIDS. THE SECONDARY GOAL IS TO PROVIDE A NEW REVENUE STREAM TO SUPPORT THE MISSION OF FORKIDS.
