FORKIDS SERVED 1,164 PEOPLE, INCLUDING 710 CHILDREN IN ITS PROGRAMS DURING FISCAL YEAR 2015. OUR RESIDENTIAL PROGRAMS PROVIDED 85,115 BED-NIGHTS FOR HOMELESS FAMILIES.
